Johann Ludwig Tiarks (1789-1837), a native of Jever, Germany, was Assistant Librarian to Sir Joseph Banks, 1810-1816, and through Banks' patronage was appointed Astronomer to the British Boundary Commission under the Treaty of Ghent. After making observations in Canada, 1817-1821 and 1825, Tiarks assisted in preparation of the British case for arbitration by the King of the Netherlands. He was also employed for a time by the Admiralty in determining latitudes and longitudes.

Portions of Dr. Tiarks' papers were deposited in the Huntingdon Library from 1949 until 1972, when they were transferred to the custody of the Public Archives and additional papers were presented by Mr. Henry F. Tiarks of Foxbury, England.

Finding Aid No. 829 provides a detailed description of the items, with subject and nominal indexes, a table of contents grouping records by their nature and date, and a list of the maps transferred to the National Map Collection.

The papers of Johann Ludwig Tiarks include journals of his travels and observations, 1817-1825, recording astronomical, geographic, meteorological and other scientific data as well as opinions on social customs, the economy, and Indian languages; private and official correpsondence, 1810-1837, including copies of correspondence with the Foreign Office and the Boundary Commission; reports, accounts and related papers of the Boundary Commission and the arbitration, 1817-1834; copies of his scientific papers, 1818-1829; and miscellaneous items reflecting his interest in philology and linguistics (including Indian languages) and a variety of other subjects. The papers have been retained in the order of their reception, as the collection had been bound.

INTRODUCTION

Biographical and historical notes:

Johann Ludwig Tiarks was born at Jever in the Grand Duchy of Oldenburg in May 1789 and died there 1 May 1837. He studied theology, languages and mathematics at Göttingen, receiving his doctorate from that university in 1808. After travels in Germany and Holland, Tiarks accepted a position as assistant and librarian to Sir Joseph Banks, President of the Royal Society, and established himself in London in 1810. Under Banks patronage, Tiarks met many of the leading scientific minds of Europe, and in 1817 obtained appointment as British Astonomer on the Boundary Commission established under the 5th Article of the Treaty of Ghent.

Tiarks' interests and abilities were strongly suited to his work with the Boundary Commission. His correspondence reveals a growing interest in and influence upon the questions of interpretation raised by several terms to define the boundary line. The years spent ascertaining 'the Northeastern Boundary', from the St. Croix River to St. Regis, 1817-1821, proved to be only the beginning of Tiarks' association with boundary questions. He returned home in 1822 to marry Antoinette Sophie Toel, but soon resumed work on geographical matters: the determination of longitudes for the Board of Longitude of the British Admiralty, 1822-1824. In 1825 he returned to North America to make the astronomical and other observations necessary to determining the most northwesterly point of the Lake of the Woods. On returning to England he undertook to assist in preparing the British case for arbitration and presenting it at the Hague, 1826-1830. When adjustments of the settlement were made, 1832-1835, he was again involved. His last years were spent in Jever.

Tiarks' papers reflect his many interests and support the statement made in several obituaries that there were few subjects connected with the sciences, the literature, the political constitution or the manners and customs of the countries in which the various portions of

his life had been spent on which he could not at once supply a fund of information. He was elected a member of the Royal Society in 1825 and contributed greatly to the communication of scientific knowledge by translating works of wide interest and procuring books for his colleagues in England. He also contributed articles to the PHILOSOPHICAL TRANSACTIONS, the MEMOIRS OF ASTRONOMICAL SOCIETY OF LONDON, the PHILOSOPHICAL MAGAZINE and other learned journals. (Lists of his publications appear in Files xix, xxii and xxxv. Further information might be obtained from Charles A. H. Franklin's A SHORT HISTORY OF THE FAMILY OF TIARKS OF FOXBURY.)

Previous historiography has frequently failed to appreciate the significance of scientific achievements and the careers of such men as Johann Ludwig Tiarks. The settlement of the boundary as defined in the Treaty of Ghent, 1814, hinged upon the work of geographers, astronomers, surveyors—all those able to provide some correlation between the terms of the treaty and the actual land masses. Studied in conjunction with the Foreign Office papers (MG 13) and papers of such men as Ward Chipman, British Agent on the Commission (MG 23, D 1), the papers of J.L. Tiarks provide a most significant and valuable insight into the boundary settlement question.

<u>Provenance</u>

The papers of Dr. Tiarks were retained by several members of his family until 1972. A portion of them were placed on deposit at the Huntingdon Library, San Marino, California, between 1949 and 1972. The papers had passed from Johann Ludwig to his daughter Louise (wife of the historian Heinrich von Ranke), to her daughter Amalia von Ranke, wife of Alfred Perceval Graves, to their son Robert Graves (the poet and author). Graves passed the papers to his cousin, Henry F. Tiarks, a descendant of John Gerard Tiarks (the brother of Johann Lugwig), who had been Chaplain to the Duchess of Kent (mother of Queen Victoria)

INTRODUCTION (cont'd)

The majority of the items were bound in 1931 and the volumes all bear the bookplate of Frank Cyril Tiarks of Foxbury, Kent. When Henry F. Tiarks authorized the transfer of those items at the Huntingdon Library to the Public Archives of Canada, he also selected and presented to the Archives further items from the collection which has remained with the family. However, Mr. Tiarks retained those items considered to be duplicate as well as several of special interest, for his own library. The bound volumes all bear roman numerals of which the following do not appear on items placed in the Archives: iii-v, vii, xi-xiii, xv, xvii and xxvi. For clarity, these numerals are referred to below as 'file numbers'. Arabic numerals have been assigned to the items received directly from Mr. Tiarks.

The items received from the Huntingdon Library have been boxed as Volume 1-3 and those received directly from Mr. Tiarks as Volumes 4-5. The specific breakdown is as follows:

As can readily be seen, there are several breaks in the sequence of roman numerals. While in transit to the Huntingdon Library, the collection was water-damaged, several items irretrievably. Those items included some drawings and manuscripts, chiefly studies of Indian languages.
