DUNN, James Hamet (1875-1956) Financier, Industrialist

Originals, 1905-1955, 44.15 m. Finding Aid No. 841

Sir James Dunn was born in Bathurst, New Brunswick, the son of Robert H. Dunn and Elizabeth Joudery. After studying law and embarking upon a legal career, Dunn entered business life. He became a member of the Montreal Stock Exchange in 1902 and founded the banking firm, Dunn, Fischer and Company, in London, England in 1907. One of his financial triumphs was the merger leading to the creation of Brazilian Traction, Light and Power Company (Brascan). In 1935 Dunn became Chairman and president of Algoma Steel Corporation. He was created a baronet in 1921. Sir James Dunn married three times, his third wife being Marcia Anastasia Christoforides, the present Lady Beaverbrook.

Personal Correspondence, 1905-1955. 28.95 m (Volumes 1-309A)
Letters, letterbooks, telegrams, accounts, notes, and memoranda relating to Dunn's personal and business career. A small initial section, 1905-1908 (Vols. 1-5) deals with J.H. Dunn and Company and is followed by an extensive section of general correspondence dating from 1906 to 1939 (Vols. 5-205, 248-309A). A final section, covering the period 1940-1955 (Vols. 206-247) attempts to distinguish between family, personal and financial correspondence and appears to have been created for estate purposes.

Algoma Steel Corporation, 1931-1955. 6.8 m (Volumes 310-342)
Correspondence, financial summaries and clippings dealing with a variety of topics of interest to the steel firm, including company administration, relations with municipal, provincial, and federal governments, and arrangements with suppliers and buyers.

Miscellaneous Business Records, 1905-1954. 8.4 m (Volumes 343-403)
Varied material detailing the extent of Dunn's interests. Included are files on Lake Superior Investments, North American Arms Company, English Construction Company, Deutsche Bank, Del Rio, Empire Trust Company and many other firms. There are also files on Philip Dunn, Sir James's son, and Maurice Duplessis.

The following finding aid reflects the way in which Sir James Dunn kept his papers. Material dealing with his private interests was grouped chronologically and within time periods, alphabetically. The finding aid for this section is a shelf list with brief descriptive subject notes. When the correspondence dealt with Dunn's business affairs, it was kept by subject and the finding aid is, accordingly a list of file titles.

Volumes 184-237 are restricted. Researchers are advised that these volumes are closed pending final settlement of the items of access with the donor.
