The Home Bank of Canada (1903-1923), a federally chartered bank with its head office in Toronto, Ont., grew out of the long-established Home Savings and Loan Company. During the Home Bank's twenty years of existence, its business expanded to include seventy branches located in most major Canadian cities, as well as in numerous towns and villages. As early as 1914, the bank began to experience difficulties which were blamed on its inefficient management. By 1916, the Minister of Finance, Sir Thomas White, received complaints about the bank but refused to order an investigation. He believed that an inquiry at that time, irrespective of its outcome, would only result in the destruction of credit. The fear of precipitating a bankruptcy in wartime and the bank's promise of a reorganization of the Board of Directors, convinced him to defer immediate action on the problems.

On 17 August 1923, the Home Bank was forced to suspend operations after failing to balance its accounts at the Toronto head office. After demonstrating its inability to prove or regain solvency and after the termination of the 90 day compulsory suspension period, the bank's assets were liquidated. The failure of the Home Bank caused serious financial loss to its 60,000 depositors, most of whom never received full reimbursement, and to most of its 1,686 shareholders. After numerous petitions to the federal government for relief, the case was taken to the courts. Five directors, an accountant and auditor were all found guilty of conspiracy and filing false returns and were sentenced to imprisonment; a conviction that was cancelled upon appeal. In 1925 a Royal Commission studied the matter and, as a result, Parliament made partial restitution to the depositors.

Head Office Records, 1905-1924. 7.32 m (Volumes 1-36).

Correspondence, minutes, reports, memoranda, financial records and other material concerning the Head Office, its operations and interests. The records are filed alphabetically by file title.

Double Liability, 1924-1936. 2.04 m (Volumes 37-46).

Files and correspondence relating to the collection of double liability obligations. Volumes 37 to 44 contain correspondence filed alphabetically under the name of the individual in question. Volume 45 contains head office correspondence regarding double liability suits; correspondence with Ludwig and Ballantyne, and statements and a memoranda to liquidators concerning western liability. Volume 46 contains miscellaneous related material.

Claims, 1923-1930. 3.26 m (Volumes 47-62).

Files basically consist of claims by depositors against the bank which are organized by branch, 1925-1926; claims and correspondence with other Canadian and American banks, 1923-1927; correspondence concerning depositors claims, 1923-1930; material on preferred, unsettled, approved and disallowed claims, 1923-1928; and other related material. Also included is correspondence with the Department of Justice and the Exchequer Court of Canada, 1926-1928.

Depositors Relief Association, 1923-1931. 1.22 m (Volumes 63-68).

Correspondence, minutes, petitions, reports, resolutions, white slip fund material and circulars related to the Depositors Relief Association. The D.R.A. was formed at the insistence of I.E. Weldon, Commissioner during the liquidation of the banks operations.

Loan Data, 1886-1932. 5.26 m (Volumes 69-84).

Material related to the Home Bank and to the Home Loan and Savings Corporation. Volumes 69-77 contain head office material concerning loans to individuals and hypothecations (filed alphabetically). Volumes 78-84 concern victory loans, specific loans to companies, securities and trade bills.

Stocks and Bonds, 1905-1923. 91 cm (Volumes 85-97).

Records of the sale and purchase of Home Bank capital stocks and bonds. Included are capital stock ledgers, registers, receipts, applications, correspondence, dividend cheques and statements.

Liquidation, 1923-1929. 4.05 m (Volumes 98-119).

Material mainly consists of claims by the bank filed by the name of the individual concerned (Saskatchewan branches), 1923-1929; alphabetically filed material on individual's outstanding debts, setoffs by bank branch, 1923-1924, and other papers concerning the liquidation of the Home Bank assets.

Court Records, 1910-1926. 7.32 m (Volumes 120-158).

Correspondence, accounts, court exhibits, evidence, lawyers notes, court records, ledger sheets, financial summaries and numerous other types of documentary evidence presented to the Exchequers Court during the prosecution of the Bank directors. Parts A consists of files relating to the major individuals concerned, Part B contains supplementary documentation.

West Coast Properties, 1911-1930. 1.43 m (Volumes 159-165).
Correspondence, ledgers, certificates, financial statements,
reports and other material concerning west coast properties
such as B.C. Timber, Colonial Lumber and Paper Mills Limited,
Enterprise Cattle Company Limited, West Coast Collieries, and
Port McNeill Property.

Weldon, I.E., 1914-1936. 3.87 m (Volumes 166-184).
I.E. Weldon was the solicitor responsible for closure of
operations of the Home Bank of Canada. His papers contains
many details about the bank's closure as well as material
on the Canadian Railway Relief Association (CRRA), 1932-1935;
Beauharnois, 1931-1936, and other subjects commonly found
in solicitors papers.

Ledger List, 1879-1924. 94.54 m (Volumes 185-826).
Ledgers relate to current accounts, liability, savings,
security, loans, and other subjects and are organized
alphabetically by bank branch.
