Born and educated in Ireland, E.R. Meredith came to Canada in 1842. In 1844 he was called to the Bar, but he never practised law. He was appointed principal of McGill College in 1846. He resigned this office in 1847 to accept the position of Assistant Provincial Secretary, Canada West. In 1867 Meredith became Under-Secretary of State for the Provinces and in 1873 he was appointed Deputy-Minister of the newly-created Department of the Interior. He retired from the Department in 1875. Meredith was an active exponent of prison and he served with the Canadian Prison Board for 10 years. In 1891 he was appointed to a Commission enquiring into the administration of Kingston Penitentiary. He was also a member of several library and scientific societies and the author of several publications.

The bulk of the collection was presented in 1968 by Mrs. A. Garneau of Ottawa.

William Meredith was the brother of E.A. Meredith. William emigrated to Canada where he studied law and in 1863 was called to the Bar of Lower Canada. He became a judge of the Superior Court of Lower Canada (1852-1859) and a judge of the Court of Queen's Bench, (1859-1866). From 1866 to 1884 he was Chief Justice of the Superior Court of Quebec and was Knighted in 1886.
