Permanent Volumes

- Vols. 1-5 NO COPYING - These volumes are open for research.¹ However, there is to be no photocopying of any correspondence in the files except with the permission of P.K. Page.²
- Vols. 6-11 RESTRICTED - During P.K. Page's lifetime all researchers wishing access to the material in Correspondence Series I must sign a form undertaking not to use the papers for purposes of publication without the prior consent of P.K. Page and, where applicable, her correspondent.¹ There is to be no photocopying of the material except with the express permission of P.K. Page.²
- Vols. 12-20 NO COPYING - See vols. 1-5 above.
- Vol. 21 RESTRICTED - Restricted during P.K. Page's lifetime. Researchers must obtain her written permission to consult.²
- Vol. 22 Open.
- Vol. 23, files 1-3 RESTRICTED - The Canada Council 1977-1989 files are restricted during P.K. Page's lifetime to all researchers unless they have her written permission to consult them, with the proviso that researchers given access sign an undertaking that they will not disclose any information that could reasonably be expected to identify grant applicants who have not been dead at least twenty years and that they will not disclose any advice or recommendations developed for the Council by its staff or any confidential financial information supplied to the Council by other parties without the permission of the Assistant Director and Secretary to the Council.²
- Vol. 23, file 4 RESTRICTED - The Canadian Writers Foundation 1976-1983 file is restricted, until fifty years from the date of each document have elapsed, to all researchers unless they have the written permission of P.K. Page to consult it or, after her death, that of the President and one other Director of the Canadian Writers Foundation.²
- Vol. 23, file 5 RESTRICTED - The Order of Canada 1980-1981 file is restricted, until thirty years from the date of each document have elapsed, to all researchers unless they have the written permission of P.K. Page to consult it or, after her death, that of the office of the Order of Canada, Rideau Hall.²
- Vol. 24 CLOSED - The Personal Correspondence is closed until 1 January 2034.
- Vols. 25-28 NO COPYING - See vols. 1-5 above.
- Vols. 29-32 RESTRICTED - See vols. 6-11 above.
- Vol. 33 RESTRICTED - The correspondence in the Correspondence Series II is restricted during the lifetime of P.K. Page and that of the relevant correspondent, or until the year 2034, whichever is the shorter period. During the period of restriction, all researchers must obtain P.K. Page's written permission,

during her lifetime, or that of the relevant correspondent, after her death, in order to consult any document.²
