Category 1 In order to obtain access and photocopying privileges for files less than 20 years in age, researchers must: (1) obtain the written permission of Gregory J. Dyck (address below); and (2) complete an "Application for Access" form at the National Archives. Files over 20 years in age are open; for access to open files in restricted volumes, contact the Economic and Public Archives Section of the Political & Social Heritage Division.

Category 2 For access and photocopying privileges, researchers must obtain the written authorization of Gregory J. Dyck (address below).
