When the building which housed the Dominion Laboratory of Plant Pathology recently was demolished, the records were boxed and transferred to the Agriculture & Agri-Food Canada Library at the Fredericton Potato Research Centre. The materials were not organized in any chronological order, and due to the time restraints of the project, emphasis was placed on producing a detailed box, case, and file listing inventory rather than sorting materials into chronological order. A selected index is provided as a guidepost to the searcher.

The collection contains records dating from 1915 to the mid 1970s. It includes detailed administrative and financial records; general correspondence; files on specimens examined; press articles and circulars; summaries of agricultural conditions; records relating to other laboratories such as Kentville, Charlottetown, and Winnipeg; results of the annual Plant Disease Survey; reports on various investigations or studies; and monthly, weekly, and annual reports of the Laboratory's activities.

Also included in this collection is material related to the Saint Peter's Credit Union Ltd.
