THE COURT STONE PAPERS

(Donated to the NATIONAL LIBRARY by Mrs. Maireen Johnston. and taken from Orillia by Peggy and Jay Atherton. June 10th. 1984).

NOTES

We worked with Kaireen (ner wish) on sorting out C. Stone's papers, etc. We started at 5.00 p.m., on Saturday, working until 3.30 a.m. Sunday morning, and continued after preakfast on Sunday morning, finishing shortly after noon.

THE MUSICALS

TRAUMEREI

Several copies of this. the last musical, had been made. As the National Library only needed one - preferably the original score and script - Kaireen and I sorted through all the copies to retreive these (scattered throughout the various copies). Hopefully, the musical material is complete. Excerpts from the musical, performed in Sept. 1982 with C. Stone at the piano, can be obtained from the singer, Miss Donna Trifunovich (31 Elginfield Dr., Guelph, Ont. N1E 4E5).

MUSKOKA HOLIDAY `

Kaireen had had difficulty in locating the music for this, as it had been loaned out. However, a recording had been made at the time of production, and Kaireen copied this onto a cassette, which she has donated.

TAPES AND CASSETTES

Kaireen does not know what is on the tapes. However, she mentioned that during the period when his taping equipment was still a novelty, Court used to susprise unsuspecting family members by recording them. He also would record the performance of pupils during their lessons (my own recollection). I remember, for example, his recording my performance of <u>CANADIAN RHAPSODY NO. 1</u> in 1958 or 1959. I suspect that many of his plano works were recorded in this way shortly after completion.

Mrs. MacDonald (c/o her daughter Nadine, 227 Ellis Ave., Toronto, Ont. M6S 2X4) has asked Kaireen for copies of the playing of her son and daughter, both child prodigies. Kaireen, however, doesn't know which tapes these are on, if still extant. If they can be located Mrs. MacDonald should be notified.

There may be an improvised interview done by C. Stone and his mother (which he once played for me) on one of the tapes.

MANUSCRIPTS

Kaireen mentioned that she had taken this material from wherever Court had stored it. and put it into the 2 boxes we sorted through. The original order has no doubt been destroyed in these two processes. There are manuscripts of both published and unpublished works for plano and plano and voice. There are many musical notes, some difficult to match up with preliminary and concluding material. The unpacking and sorting of this material must be done carefully.

PUBLISHED MATERIAL

The published piano works have already been deposited in the However, as Dr. Kallmann had expressed National Library. interest in music and books with a Canadian imprint, Kaireen nad set aside some old books from Court's library. She also suggested that we go through what remained of the music left by Court. (He had offered his music to his teaching colleagues, suggesting that they take whatever they might find useful). We selected out texts and music (mostly sheet music) having a Canadian imprint, or Canadian place of publication listed in the imprint. not select out those having only a Canadian distributer state-There was other music - much of it fold, some having been published in the last century. Uncertain of its value, 1 selected a few items for inclusion in the collection (mostly studies, or technical exercises). I selected some texts for the collection, (those with a Canadian imprint) but neglected to look at some others in a box that had been set aside. (By this time it was 3.30a.m.)

Kaireen also gave me some old 78rpm recordings of Canadian interest, and a stack of early issues of Etude (box 9).

Apart from clippings of reviews done by Court, I noticed fairly fort, Hung there were many clippings scattered throughout his papers, Tourse, List, Hung these, e.g. "your morning smile" that he had out --that there were many clippings scattered throughout his papers, of jokes, e.g. "your morning smile" that he had cut out, and that obviously appealed to his sense of humour. I did not select most of these for inclusion in the collection.

There are 2 scrapbooks of clippings, one compiled by Mrs. Louise Stone, and one by Court.

ARTISTIC WORKS

Included in the collection is one watercolour and some pencil drawings done by C. Stone. Some of his works remain in Orillia (including water colours of 85 Glengrove Ave. and his grandparents' farmhouse at Cavan) and possibly some of his attempts in oil, done under the tutelage of the artist A. Shilling. The file kept by Court on the artist A. Shilling is included. It contains some original drawings by the artist.

NOTES ON COURT STONE'S STUDIO

The following artistic items were collected by Court Stone during his teaching career, and were on display in his studio at the time of his death:

- A large painting of Robert and Clara Schumann, commissioned by C. Stone?
- More than 20 works of art by the Canadian artist, Arthur Shilling (mostly done in oils).
- Portraits (done in oils) of many composers. commissioned by C. Stone, and painted by Norene Peters?
- A large painting with an Eskimo theme, done by Norene Peters.
- A large bust of Chopin, commissioned by C. Stone, and done by Francis Hahn?
- Several other paintings, including an oil portrait of a Jamaican woman.
- In the den, a large painting of Mona Bates hung, commissioned by C. Stone, and completed by N. Peters. It was done from a photograph showing Miss Bates seated in front of an earlier portrait of herself as a young girl.

At one end of the studio Court had hung a selected number of photographs of students, himself, and others.

He also had in his studio two Steinway grand pianos purchased from Mona Bates before her death in the 1960's. However, before that time he had had other grand pianos (2) for use in teaching. In the Orillia studio he had also a small organ, and a small harp, perhaps old family possessions? On a wall hung a Chinesestringed instrument.

These: and many other items of interest (including unusually carved tables and chairs, sofas, decorative lamps, colourful rugs, a collection of folding chairs for concerts, a bar for entertaining, and a photocopier) made up the teaching environment of Court Stone. A winding staircase at one corner of the studio gave access to an upstairs room. (and outside that a deck) where students could wait for their lesson.
