


INTRODUCTION

Gerald William Baldwin's files were assigned consecutive numbers as each new file was created; however, the files were not maintained in numeric sequence and some files on the same subject carry greatly disparate designations. With the exception of the series on the Public Accounts Committee and on Freedom of Information, there was no apparent system - numerical; subject; chronological; or ministerial - for keeping the files within the office. In order to facilitate research, the Member's series was arranged alphabetically by subject and the numeric designations on items within the files were not used.


