

Mr. William R. McIntyre was born in 1918 at Lachine, Quebec and was educated at the Central Collegiate Institute, Moose Jaw; and the University of Saskatchewan, Saskatoon. During World War II he served with the Royal Canadian Artillery, trained as an ariel observation pilot and served with the 666 Aerial Observation Squadron. In 1947 he was called to the Bars of Saskatchewan and British Columbia and practiced law in Victoria, B.C. until 1967. In that year he was appointed Justice to the Supreme Court of British Columbia and remained in that capacity until he was appointed a member of the Justice Court of Appeal for B.C. in 1973. In 1979 he was appointed a judge of the Supreme Court of Canada and served in that position until his retirement ten years later.

Finding Aid no. 1830 consists of a list of file titles, organized alphabetically in three series.

Papers of William R. McIntyre documenting his career as a Judge with the Supreme Court of Canada between 1979 and 1989. The papers consists principally of personal files, speeches and Case note books that were accumulated during his ten years as a Supreme Court Judge.

Subject Files. Original, 1979-1989, 1.150 m. (Vol. 1-6). The subject files cover a variety of major legal issues including education, television in the court room, and civil liberties and the Charter of Rights.

include: ethics, evidence, public perceptions of the law,
activism and the law, and structure and trends of the
legal system.
