#### **Biographical Sketch**

Archibald Edward Malloch was born in 1926, the son of Dr. Thomas Archibald Malloch and Katharine Abbott, and served during the Second World War with the Royal Canadian Signals Corps from 1944 to 1945. He received his BA from Queen's University in 1948 and did his graduate studies at Harvard and the University of Toronto. Northrop Frye was the dominant figure in the Department of English at Toronto in those years but Malloch studied under Marshall McLuhan, who had not yet risen to prominence, and formed a lasting friendship with him. He received his PhD in 1958 for his critical study of John Donne's Biathanatos. Malloch taught English at McGill University from 1954 to 1988 where, in addition to teaching and writing on English literature, he became active in the Canadian Association of University Teachers and served as the Chair of its Academic Freedom and Tenure Committee from 1970 to 1974. As a result of the expertise he developed in this area, he was much sought after to serve on committees of inquiry and boards of arbitration to resolve academic grievances and disputes. Malloch received the Milner Memorial Award from the CAUT in 1979, which is given only occasionally, for his distinguished contribution to the cause of academic freedom, and received the Noel Fieldhouse Award from the Faculty of Arts at McGill University in 1988 for excellence in teaching. Further recognition of his contributions came with the publication of a collection of essays in his honour, Literature and Ethics: Essays Presented to A. E. Malloch (Montreal and Kingston: McGill-Queen's University Press, 1988), edited by Gary Wihl and David Williams.

### Scope and Content note

The fonds consists of records relating to Archibald Malloch's life and work as a Professor of English at McGill University, including material relating to his friendship with Marshall McLuhan, work with the Academic Freedom and Tenure committee of the Canadian Association of University Teachers, participation in the resolution of academic grievances and disputes, and scholarly research and writing on literature, religion and other subjects.

#### **Series:**

#### Marshall McLuhan series (Vol. 1, 5 cm, 1949-1970)

This series documents the friendship between Archibald Malloch and Marshall McLuhan which formed while he studied under McLuhan as a graduate student at the University of Toronto. It comprises forty-six letters from McLuhan to Malloch, four letters from Malloch to McLuhan, a review of McLuhan's books by Malloch, and issues of McLuhan's early mimeographed occasional publications "Network" and "Media Log". The correspondence largely predates McLuhan's rise to prominence in the 1960s and provides a glimpse of his thought during the period that he was working on *The Mechanical Bride* and *The Gutenberg Galaxy*. His letters discuss the philosophy of Jacques Maritain and Stéphane Mallarmé, the writing of T. S. Eliot and James Joyce, McLuhan's conversion to Catholicism, trends in communications, misadventures while sailing, the work of Northrop Frye, the effect of print culture on human habits of learning and attention, and other subjects of interest to them.

### Correspondence series (Vol. 2, 20 cm of textual records, 1 photograph, 1948-1990)

The series comprises Archibald Malloch's personal and professional correspondence documenting his career as a Professor of English at McGill University, his research and writing, and his involvement in the defence of academic freedom and tenure and the resolution of academic grievances and disputes. Frequent correspondents include other professors from his department, his students, and participants in university arbitration cases. There are eleven letters from Walter Ong, the influential Jesuit intellectual and communications theorist. There is also a considerable amount of material relating to the John Fekete dispute at McGill in 1967 and its aftermath. Other letters mention his receipt of the Milner Award from the CAUT and the Noel Fieldhouse Award for excellence in teaching from McGill.

#### Writings series (Vol. 3, 20 cm of textual records, 1948-1994)

The series consists of articles, book reviews, occasional papers and other writings of Archibald Malloch. It includes his graduate student essays at Harvard and the University of Toronto; Master's thesis, "No Substitute for Sense: A Survey of Recent Criticism of the Metaphysical Effect in Donne's Poetry"; PhD thesis, "A Critical Study of Donne's *Biathanatos*"; articles of literary criticism in a variety of scholarly journals; articles on Americanization, academic freedom and tenure, and other issues of concern in Canadian universities; annual reports of the Academic Freedom and Tenure committee of the Canadian Association of University Teachers, 1971-1974; articles on religious belief and devotion; and manuscripts of lectures, talks, addresses, and letters to the editor.

**Academic Freedom, Grievances and Disputes series** (Vol. 4, 20 cm of textual records, 1969-1994)

The series comprises Archibald Malloch's case files relating to academic grievances and disputes with which he was involved as Chair of the Academic Freedom and Tenure committee of the Canadian Association of University Teachers or as a member of boards of arbitration or committees of inquiry. His case files hold personal correspondence with participants, memoranda, notes of hearings, and reports of findings. The most heavily documented case is that of the dismissal of several professors in the social sciences at Simon Fraser University, 1969-1970, and the resulting strike by sympathetic members of the faculty while Malloch was chairing the Academic Freedom and Tenure committee. Other notable "group" cases involved the University of Victoria, 1971-1974, and the University of British Columbia, 1985-1987. There are also files for disputes concerning individuals for Srinivasa Santhanam, John Fekete, Pauline Vaillancourt, Arnim Arnold, Alfred Vanasse, R. N. Verdery, M.F. Islam, Philip Teigen, Anne S. De Fabry, and S. Heeren. In addition, the series contains Malloch's "Report of the Fact-Finder on the Procedures used in the Appointment of a Person to Chair the Academic Freedom and Tenure Committee" (1981) and related correspondence.

#### **Student Roll Books series** (Vol. 5, 5 cm of textual records, 1954-1967)

The series consists of Archibald Malloch's student roll books for the courses he taught in English at McGill University from 1954 to 1967. The roll books list the names of students and their grades for essays, assignments, reports, tests, and exams. In addition, there is a small amount of loose correspondence and other material relating to students.
