VICTORIA AND GREY TRUST COMPANY (1950-1984)

Originals, 1884-1982. 3.5 m. Finding Aid No. 1674.

The Victoria and Grey Trust Company was created in 1950 by a merger of two Ontario trust companies, the Victoria Trust and Savings Company and the Grey & Bruce Trust & Savings Company. The former company had been chartered as the Victoria Loan and Savings Company in Lindsay in 1895, and had become a trust company in 1923; by 1950 it had branches in Lindsay, Belleville and Cannington. The latter company was founded in Owen Sound in 1889 as the Owen Sound, Grey and Bruce Loan and Savings Company. It changed its name in 1897 to the Grey and Bruce Loan Company and merged in 1926 with the Owen Sound Loan and Savings Company to form the Grey & Bruce Trust & Savings Company. By 1950 the firm operated branches in Owen Sound and Peterborough.

Through the 1960's and 1970's the new firm undertook an aggressive program of expansion. A merger with British Mortgage & Trust Company in 1965 brought 15 additional branches to the firm, purchase of Lambton Trust Company in 1969 another six. The Metropolitan Trust Company, along with its subsidiary the Canadian First Mortgage Company, was absorbed in 1979-1980. At the same time the firm continued to establish new branches, most of them in rural Ontario. In 1974 the firm began expanding into western Canada with the establishment of a branch in Edmonton; by 1982 it had ten branches in the four western provinces, along with another three in Quebec. In the same year the firm had a total of 88 branches and total assets of \$3.8 billion. In 1984 the firm merged with National Trust Company to form National Victoria and Grey Trustco.
